The Import and Export Port Related Charges listed below are administered and invoiced by MCP plc on behalf of the Terminal Operator. While they are presented as advisory information by MCP plc, these charges do not represent fees imposed by MCP plc for providing or using Destin8 functionality.

All invoicing and collection of security, examination and SOLAS VGM related charges is a supplementary bespoke service provided to Terminal Operators and is outside of the Destin8 core functionality. This service is not covered by our standard terms and conditions. Fees are subject to change by the individual Terminal Operators, fees included in this schedule are correct at the time of publication.

Any queries or disputes on rates, charge party and/or failure to settle import or export port charges raised on behalf of Terminal Operators are for the Terminal Operator to resolve directly with their customers.

Please note that this schedule of port-related charges is not exhaustive. It only outlines charges where MCP plc serves as a collecting agent on behalf of the specific Terminal Operator. Operations in any Port may still attract Port related charges which will be invoiced directly by the Terminal Operator.

STIPULATED CREDIT TERMS

Unless other credit/deposit terms apply to the particular End-user:

- 1) Port related charges are invoiced monthly. All sums are to be paid within 28 days of invoice date.
- 2) Sums not paid within such time shall carry interest at the rate of 2% per annum above the base lending rate (LIBOR) from the date of invoice to the date of actual payment.
- 3) All sums are net of VAT or other applicable sales tax.
- 4) Where shortened credit or deposit terms apply to the particular End-user, then a right of disconnection without notice shall apply in the event of the End-user failing to honour such terms.
- 5) Payment of all amounts due shall be made by you in full without any deductions whatsoever by direct debit or Direct Bank Payment only.
- 6) We may impose a charge of £15.00 (or such other sum as we may from time to time reasonably determine) to cover our costs in the event that your payment is not honoured by your bank or other financial institutions.
